Rules and Regulations:

Driving to school and parking in the school parking lot is a privilege granted to students with a valid driver's license. Students must be aware of the restrictions and adhere to all regulations to maintain their driving privileges. Students who fail to comply with these rules and regulations will forfeit their driving privilege at administration's discretion.

The following rules and regulations apply to student drivers:

1. Obey traffic directions of any teacher or administrative staff member.
2. Obey the speed limit of 5 MPH.
3. Reckless driving is unacceptable.
4. Obey all signs and painted pavement restrictions.
5. Buses/vans always have the right-of-way.
6. There will be no unauthorized driving on campus, including loitering in or by cars in the parking lot.
7. Students are not to return to their cars during the school day (including lunchtime) unless they receive permission from the Main Office.
8. Student drivers must wait for the student driver dismissal announcement before leaving their homeroom for the school day.
9. Student drivers are only to park in specified areas of the parking lot – see Upper School Principal for allowed locations.
10. Student drivers are not permitted to drive for field trips, athletic events, games, extracurricular events, etc. All students must ride on CSY vehicles for these events.
11. Music being played inside a vehicle is not to be played so loudly that it can be heard outside the vehicle.
12. Parents/guardians are fully responsible to set and enforce rules and boundaries with their own student(s) in regards to passengers. CSY is not responsible for monitoring a student driver's passengers.

13. A student's driving privileges can be suspended or taken away entirely due to attendance/tardy consequences, leaving before student driver dismissal, general mischief, misconduct, and/or vehicle use that may jeopardize the safety of others.
14. CSY is not responsible for any damage that may occur to vehicles while parked in the school parking lot (during school hours and/or after hours). CSY cannot be responsible for stolen or lost items.
15. Any student that graduates or withdraws from CSY needs to return the parking permit tag to the school.

I have read the Student Driver Regulations and I agree to abide by these regulations. I realize that violations of these rules will result in loss of driving privileges and/or other consequences.
