This is an outdoor event: inclement weather and wind gusts may occur. Prepare accordingly.
5. If a pre-registered participant fails to report in by the specified time, the committee reserves the right to assign that space to another.
6. I also affirm that my vehicle(s) and/or my possessions are fully covered by my own necessary property damage insurance. I confirm that there is a valid and current registration for the automobile, truck or motorcycle and that the automobile, truck or motorcycle is properly insured and complies with Pennsylvania Insurance Laws.
